### ARTIST AGREES TO THE FOLLOWING TERMS:

1. Artist agrees to remain set up during ALL open hours of convention. **NO EARLY BREAKDOWN!**
2. Artist agrees not to move tables, place anything in front of/or beside tables or interfere with any neighboring exhibits. (aisle distance is exactly measured to fire marshal regulations)
3. Any damage to the building by a dealer is the sole responsibility of the Artist. Exhibitor understands that solicitation of dealers and/or customers is strictly prohibited.
4. No Artist setup sound systems without promoter permission.
5. No smoking or alcohol is permitted in the exhibit hall at any time.
6. Artist understands payment policy and agrees to pay the fees as listed. No tables are guaranteed until payment is received. Checks with insufficient funds will be charged a \$25.00 service fee.
7. No refunds or roll-overs for tables.
8. Subletting is not allowed without the consent of convention promoter.
9. Sharing of tables is not allowed without the consent of convention promoter. If approved, the person whose name appears on this contract assumes full responsibility for the table(s).
10. Artist selling unlicensed or bootleg merchandise will be ejected from convention without refund.
11. Artist agrees NOT to sell adult material. (adult magazines, adult DVD's etc...) Additionally, artist agrees not to exhibit any material exposing nudity.
12. Promoter agrees to provide overnight security but is not responsible for any theft or loss. Artist accepts full responsibility for loss and / or injury to themselves, their family, their staff and their property while attending convention. Dealers expressly release convention promoter from all liability.
13. Any Artist inappropriate behavior / conduct / language (at show promoters discretion) will result in ejection from convention.
14. Artist can receive a maximum of 2 badges per table; however artists will never receive more badges than helpers that are physically present. Abuse of Dealer Badges is considered very serious and will result in ejection from the convention.
15. Promoter reserves the right to revoke or refuse any application or to deny access to or remove artist(s) from the convention at any time prior to or during the event.
16. Artist agrees to comply with all municipal, state and federal requirements in connection with sales.
17. Promoter has full power in the interpretation and enforcement of all contract regulations contained herein, and the power to make such amendments thereto, and such further rules and regulations as shall be considered and proper.
